This is a common threat in tourism sector in Sri Lanka, but the sad part is Sri Lanka government has not been taken any active measures to counter this problem yet. Wildlife trading, bio piracy

# > Destroying image or damaging to national heritage sites of Sri Lanka

This is new threat in tourism sector in Sri Lanka - there are many unlicensed tourists guide actively involved in tourism. They either use fake licenses or operate without license. These individuals are doing great damage to the national image and national interests of Sri Lanka. Misinterpretation of illegal foreign tour leaders (Chinese on national heritage sites may not only lead to the destruction of the tourism and even lead to internal conflicts among communities of Sri Lanka.

# Immigration law violations
